<b>Working Week</b>	Where a Tuesday-Saturday week is scheduled and Sunday is worked as a 6th day, Sunday will be paid at 6th day overtime rates instead of Sunday rates.	<i>MEAA members agree for location exigencies only</i> Where a Tuesday-Saturday week is scheduled, Sunday may be paid as a 6th day in order to shoot at an otherwise restricted location.	<b>New producer proposal</b> Agree on adding location exigencies for Sunday 6th day. Saturdays to be paid as standard 5 day week rate (no Saturday 25% loading). (Producer says there will be 5 weeks scheduled Tuesday-Saturday.)

<b>Meal Breaks</b>	Meal provided after 6 hours from first call or end of previous meal. Grace period = 15mins. An extension of 30 min can be used for wrapping up or to complete the camera take in progress. Extension and grace period cannot be used together.	Meal provided after 5 hours from first call or end of previous meal (extension to 6 hours can be requested). Substantial craft services to be available from call until wrap when shooting continuous hours. <i>MEAA members agree to grace period and extension.</i>	<b>Producer improved offer</b> Meals provided after 5 hours with the ability to push to 6th in consultation with ADs, and where crew agree, before meal penalties apply.  Has indicated craft services will be available, but not at all times.
<b>COVID Shutdown</b>	In the instance of a government or COVID related shut down, employees will be stood down with 24 hours' paid notice. <b>Quarantine (travel related)</b>	The production will pay for any government charges including accommodation and will include the quarantine period as part of the period of employment, paid at 50% of the relevant weekly or daily rate plus standard per diems.	The production will pay for any government charges including accommodation and will include the quarantine period as part of the period of employment, paid at full relevant weekly or daily rate plus standard per diems.	<b>Producer improved offer</b> Quarantine period as part of the period of employment, paid at 60% of the relevant weekly or daily rate plus standard per diems.
