Scheduled Election E2018/213 NOMINATION FORM

Candidates and Nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations. Candidates must be nominated by at least one eligible financial member of the Branch. Nominations open on 8 April 2019 and must reach the Returning Officer **not later than 12:00pm** (AEST) **on 6 May 2019**. Nominations cannot be withdrawn after 12:00pm (AEST) on 6 May 2019.

It is your responsibility to ensure your nomination is received by the Returning Officer BEFORE nominations close.

Nominations must be in writing and contain the given names and/or other identifying names and place of employment and address of each candidate.

Candidates may lodge a Statement not exceeding 150 words containing Association and employment/professional history and place of employment. Statements should be emailed as a word document (.doc) to nswelections@aec.gov.au, or provided on a disc. Statements or photographs (in jpeg format and passport size if used) **must** be lodged **with** the nomination form and reach my office or postal address **not later than 12:00pm (AEST) on 6 May 2019.**
