Nominations cannot be withdrawn after 12:00pm (local time for the Returning Officer) on 6 May 2019. It is your responsibility to ensure your nomination is received by the Returning Officer **BEFORE** nominations close.

Nominations must be in writing and contain the given names and/or other identifying names and place of employment and address of each candidate.

Candidates may lodge a Statement not exceeding 150 words containing Association and employment/professional history and place of employment. Statements should be emailed as a word document (.doc) to [saelections@aec.gov.au](mailto:saelections@aec.gov.au). Statements or photographs (in jpeg format and passport size if used) must be lodged **with** the nomination form and reach my office **not later than 12:00pm (local time for the Returning Officer) on 6 May 2019**.
