Nominations open on 8 April 2019 and must reach the Returning Officer **not later than 12:00 noon (AEST) on 6 May 2019**. Nominations cannot be withdrawn after 12:00 noon (AEST) on 6 May 2019. It is your responsibility to ensure your nomination is received by the Returning Officer **BEFORE** nominations close.

Nominations must be in writing and contain the given names and/or other identifying names and place of employment and address of each candidate.

Candidates may lodge a Statement not exceeding 150 words containing Association and employment/professional history and place of employment. Statements should be emailed as a word document (.doc) vicelections@aec.gov.au or provided on a disc. Statements or photographs (in jpeg format and passport size if used) **must** be lodged **with** the nomination form and reach my office or postal address **not later than 12:00pm (AEST) on 6 May 2019.**
