It is your responsibility to ensure your nomination is received by the Returning Officer **BEFORE** nominations close. Nominations must be in writing and contain the given names and/or other identifying names and place of employment and address of each candidate. Candidates may lodge a Statement not exceeding 150 words containing Association and employment/professional history and place of employment. Statements or photographs (in jpeg format and passport size if used) **must** be lodged **with** the nomination form and reach my office or postal address **not later than 12:00 noon AWST on 6 May 2019**.
