MEAA ELECTION NOTICE

<u>Please note well</u>: MEAA has normally made arrangements for *and* conducted elections for offices in 'even-numbered years'. Due to delays in conducting the most recent MEAA elections and the declaration of all offices not being finalised until mid-2017, the MEAA Board resolved to allow members elected in 2017 to occupy those offices until 2019, instead of cutting their (two year) terms of office.

MEAA has communicated this position to the Registered Organisations Commission and have proposed that elections should be held in 2019 in line with the following key dates:

- nominations shall open on Monday 8 April, 2019
- nominations shall close on 6 May, 2019
- ballots, where required, will open on Monday 3 June, 2018 and close on Friday 21 June, 2019.

(MEAA is conveying these dates to members in 2018 because the union's rules also require that notice of elections be provided to members in 'even-numbered years'. The precise final dates will need to be agreed by the Australian Electoral Commission, so there may be some variation to the above timeframe. Further elections notices will be issued by MEAA and the AEC in 2019.]
